## 2. Nomination Committee

The Nomination Committee has been appointed by National President Senator Maric Cheng to assess the qualification and eligibility of the candidates and present a report to the General Assembly of 55th National Convention. Apart from me serving as the Chairman, the Nomination Committee includes four other members:

2002 National President Senator Tony CHAN

2010 National President Senator Gene TANG

2013 National President Senator Paul WU

2015 National President Senator Anthony LEUNG

## 3. Eligibility and Qualifications of Candidates

The procedures for the election of 2021 Elective National Officers are conducted in accordance with the Articles of Association and By-laws of Junior Chamber International Hong Kong. All candidates are required to observe and comply with these clauses therein.

The qualifications for candidates of the Elective National Offices are contained in JCIHK By-law 12-4. Specific requirements for NP, NEVPs, NVPs, NGLC, NSG, NHT and NDs are contained in By-laws 12-9-3, 12-11-2, 12-12-2, 12-10-2, 12-13-2, 12-14-2 and 12-15-2 respectively.

The Nomination Committee confirms that all the candidates fulfil the qualifications as specified in By-law 12-4 and are eligible and qualified for the offices they are standing for election and appointment with the following exceptions:

National Executive Vice President Candidate CHANG, Ming Te Ronald (JCI Island) failed to meet specific requirements under By-law 12-11-2 (A) Candidates for National Executive Vice President shall have been an Individual Member of a LOM for at least four (4) consecutive years immediately before election.

National Vice President Candidates BAR, Lai Yee (JCI Bauhinia), CHAN, Sum Yuen (JCI Tsuen Wan), CHUNG, Nga Lun Ellen (JCI Hong Kong Jayceettes), LEUNG, Hiu Man (JCI Ocean), NG, Sze Lung (JCI Sha Tin), TANG, Tsz Chung Cyrus (JCI City), YUEN, Yu Chi Kendrick (JCI Sha Tin), LOO, Yee Ka Patricia (JCI Harbour) and LEE, Man Hin Benjamin (JCI Island) failed to meet Specific Requirement under By-law 12-12-2 (C), i.e. the candidate shall be a current Member of the National Board of Directors or shall have been a Member of the National Board of Directors for at least (1) year.

Notwithstanding their failure to meet the specific requirements or qualifications, the ten candidates may seek election or appointment by way of a waiver in accordance with By-law 12-4-9. The Nomination Committee recommends such waiver be granted subject to the approval of the General Assembly by a 2/3 majority.

## 5. Interview by the Nomination Committee

Interview for all candidates for Elective National Officers, as per Constitutional requirement (By-law 12-4-7), has been conducted on 20<sup>th</sup> September 2020 at the Chamber Office by the Nomination Committee to assess the ability of each candidate in the following areas:

- i. Junior Chamber Affairs at Local, National & International levels
- ii. Parliamentary Procedure
- iii. Memorandum and Articles of Association and By-laws of Junior Chamber International Hong Kong
- iv. Duties of the respective offices and Problem Solving
- v. Community Affairs

The performance of individual candidates was graded in accordance with the following scale:

1. Excellent
2. Very Good
3. Good
4. Fair
5. Poor
6. Unsatisfactory

Interview results of each candidate in respective area are shown in Appendix 1 which was also posted on JCI Hong Kong website on or before 25<sup>th</sup> September 2020.

The results are based on the performance of the candidates in the interview session. According to the observation of the Committee, the candidates were overall confident and passionate. We agree that they are well-prepared and generally have in-depth understanding on each areas.

## 6. Closure of Nomination

In accordance with By-law 12-6-3, all nominations had been closed 45 days prior to the commencement of the National Convention.
